スリランカにおける査証申請は、査証代理申請機関（[日本ビザ申請センター](#)）を通じて行うことになっております。

査証申請にあたっては、[当大使館ホームページ](#)を再確認するとともに、不明な点、気がかりな点などございましたら、当大使館までお問い合わせください。

なお、事件に巻き込まれた場合には、最寄りの警察にご相談ください。

**Be aware of fraudulent websites, social media, emails attempting to extract payments from visa applicants**

We have received reports of fraud websites, social media and emails, falsely stating that they are issued by the Government and/or Embassy of Japan, in an attempt to extract payments from visa applicants.

Please be aware that these scams are NOT related to the Government of Japan.

All visa applications in Sri Lanka must be submitted to the [Japan Visa Application Centre](#).

Visa applicants are kindly requested to check and read the [Embassy's website](#) when applying for Japanese visas, and if there are any questions, call the Embassy for further inquiry.

If you become a victim of such fraud, please report to the nearest police station for an appropriate action.

ATTN,

We have received and considered your filled employment application form as one of our eligible potential worker. Please you should forward your filled copy of employment application form and send it to the Online Japan Immigration Office Information Travel Agency Japan with the below email address; for your visa/working permit eligibility certificate processing.

Overseas@jpn-emb.tokyo

For Processing of your JAPAN visa eligibility certificate for you, which you can take to JAPAN EMBASSY in your resident country and receive JAPAN visa without any Stress from Japan Embassy in your resident country.

NOTE;

YOU WILL BE VERY FAST TO FOLLOW JAPAN IMMIGRATION OFFICE INFORMATION AGENCY. TO MAKE SURE THAT YOU GET UR JAPAN VISA WORKING PERMIT ELIGIBILITY CERTIFICATE. WHICH YOU WILL SUBMIT AT JAPAN EMBASSY. THEY WILL CORRESPOND IMMEDIATELY TO CONFIRM FROM ONLINE IMMIGRATION BUREAU .AT CONFIRMATION OF YOUR VISA ELIGIBILITY CERTIFICATE. THEY WILL ISSUE JAPAN WORKING VISA TO YOU.

AND YOU WILL EMAIL US BACK THAT YOU HAVE RECEIVE YOUR VISA. IMMEDIATELY (*Company Name*) WILL BOOK AIR TICKET AND SEND IT TO YOU WITH YOUR FULL ADDRESS OF COUNTRY COUNTRY RESIDENCE.

I ACKNOWLEDGE THE FACT THAT THE EMPLOYER WILL TAKE CARE OF MY ACCOMMODATION AND AIR TICKET ONLY FOR APPLICANTS COMING FROM COUNTRIES CLASSIFIED AS LOW INCOME NATIONS BY THE UNITED NATION. ANY OTHER EXPENSES MADE CONCERNING THIS PROCESS WILL BE ON APPLICANT ACCOUNT.
